## 2017: A Year of Growth for Abe's Garden®

### A Letter from the Founder and Chairman of the Board

Dear friends,

Since welcoming our first residents in September 2015, Abe's Garden® has made significant progress in establishing an elevated care model of residential, day, and community-based programs for those with Alzheimer's disease and other dementias.

Thanks to generous contributions from foundations and individuals, 2017 was notable for advancements in the study and demonstration of best practices in dementia care – and dissemination throughout Tennessee, the United States, and to 102 nations across the world!

*Here's a look back at some of 2017's most significant accomplishments:*

The organization launched a series of free videos to educate family and professional dementia caregivers on a wide range of topics. The videos are available at [www.abesgarden.org](http://www.abesgarden.org) and on the Abe's Garden® YouTube channel.

Abe's Garden® Community Group (AGCG), Middle Tennessee's first community-based day program for individuals in the early stages of dementia, began providing services. AGCG promotes mind and body health, socialization, and support for impacted adults.

*The Gerontologist*® published "Managing Person-Centered Dementia Care in an Assisted Living Facility: Staffing and Time Considerations," an article co-authored by Abe's Garden® and Vanderbilt Center for Quality Aging leaders.



# THE NATIONAL NEED




**5.5M PEOPLE** in the United States ages 65+ are living with Alzheimer's. This number is projected to increase 29% by 2025, reaching 7.1M.



**APPROXIMATELY 200,000** individuals under age 65 have younger-onset Alzheimer's.




Older African-Americans are approximately **TWICE AS LIKELY** to have Alzheimer's disease or other dementias as older caucasian Americans. And Hispanics are approximately **ONE AND ONE-HALF TIMES** as likely to have Alzheimer's or other dementias as older caucasian Americans.

# THE LOCAL NEED



Tennessee's Projected Incidence of Alzheimer's. **(17% INCREASE)**

The West and Southeast are expected to experience the **LARGEST PERCENTAGE INCREASES** in people with Alzheimer's between 2017 and 2025. These increases will have a marked impact on states' healthcare systems, as well as the Medicaid program, which covers the costs of long-term care and support for some older Americans with dementia.

In 2017, Tennessee had 435K Alzheimer's disease and other dementia unpaid caregivers providing 495M hours of care which totaled \$6,252M value of unpaid care. Their increased healthcare costs equals \$279M.



# LIFE AFTER DIAGNOSIS




Studies indicate that people aged 65+ survive an average of 4-8 years after a diagnosis of Alzheimer's disease, yet some live as long as **20 YEARS** with Alzheimer's.



Individuals will spend an average of **40 PERCENT** of their total number of years living with Alzheimer's disease in the most severe stage.

# CAREGIVING REALITIES




It is estimated that **250,000** children and young adults between ages 8 and 18 provide help to someone with Alzheimer's or another dementia. National surveys have found that approximately one quarter of dementia caregivers are "sandwich generation" caregivers – meaning that **they care for an aging parent and children under age 18.**



The total lifetime cost of care (including Medicare, Medicaid, out-of-pocket expenditures, and the value of informal care) for someone with dementia was estimated at **\$341,840 IN 2017 DOLLARS.**

At age 80, approximately **75% OF PEOPLE** with Alzheimer's disease are expected to be living in a nursing home compared to only 4% percent of the general population at the same age.

# 2017 by the Numbers

Abe's Garden® was home to **56 residents**, and the Club adult day program served **25 participants**.

We hosted 82 people at Belcourt Theatre for **Hearthstone Institute's I'm Still Here®** "Meet Me at the Movies," a free community-based program for individuals with dementia and their caregivers.

Free caregiving videos were viewed over **60 thousand times** in **103 countries**.



Care partners climbed the signature career ladder through training and demonstrated competencies, with **66% completing level 1** training and **33% also completing level 2 training**.

**350 free guides** titled, "How to Evaluate the Quality of Residential Care for Persons with Dementia," which helps families choose and evaluate memory care facilities, were printed and distributed.

**Over 15K** residential nights.



Over 50 volunteers provided a total of over **1,000 volunteer hours**.

Approximately **1,000 individuals** were reached through leadership team members delivering various presentations and hosting events.

We provided tours of Abe's Garden® to **155 industry professionals** from **16 states**, helping disseminate our evidence-based care model to senior living facilities throughout the nation.





## EXPENSE BREAKDOWN (in thousands)


